ROUTES OF EXPOSURE

UNUSUAL FIRE AND EXPLOSION HAZARDS

PRECAUTIONS TO BE TAKEN IN HANDLING AND STORAGE

Section 8 - Exposure Controls/Personal Protection

PRECAUTIONS TO BE TAKEN IN USE

Use only with adequate ventilation. Avoid breathing vapor and spray mist. Avoid contact with skin and eyes. Wash hands after using.

These coatings may contain materials classified as nuisance particulates (listed "as Dust" in Section 2) which may be present at hazardous levels only during sanding or abrading of the dried film. CHRONIC HEALTH HAZARDS
